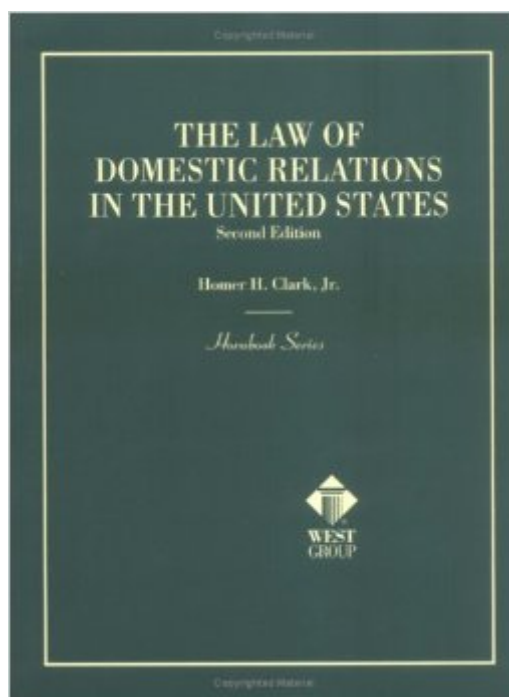

## Synopsis
