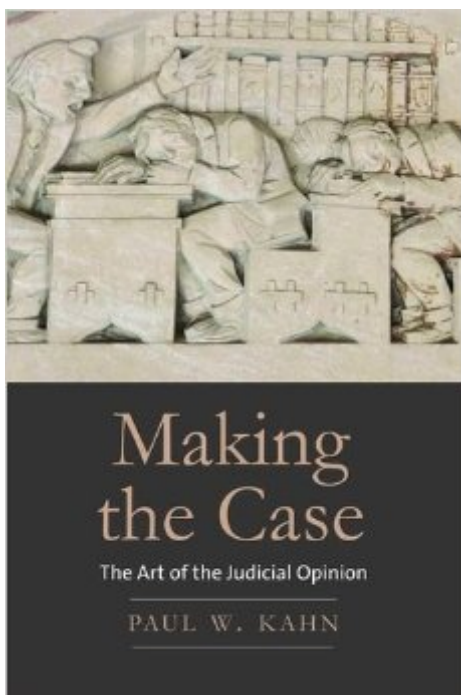

At the center of Kahn's approach are ideas of narrative, persuasion, and self-government.
